Dear Mr. Hutchinson:

This refers to the inspection conducted on December 6 to 10, 1999, at the Arkansas Nuclear One, Units 1 and 2, facilities. The enclosed report presents the results of this inspection.

In this inspection, we evaluated the effectiveness of activities conducted under your license as they related to the implementation and control of your NRC-approved fire protection program. We also reviewed your program for identifying and correcting problems associated with the fire protection program. The inspection consisted of reviewing procedures, fire brigade training and qualifications, conducting interviews with fire protection and operations personnel, and performing visual examinations of portions of the installed fire protection system, structures, and components.

Based on the results of this inspection, the NRC found that the portion of the fire protection program reviewed in this inspection was implemented in accordance with the requirements of your license.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be placed in the NRC Public Document Room (PDR).
