This report transmits the results of the subject operator licensing examinations conducted by the NRC during the period of March 12 to 19, 1999, at your facility. Based on the results of the examinations, four of five reactor operator applicants and three of four senior reactor operator applicants passed all portions of the examinations. The preliminary conclusions of the examination activities were discussed between Mr. S. Dennis and Mr. P. Orphanos of your staff on March 19, 1999.


