This report transmits the results of the subject operator licensing examinations conducted by the NRC during the period of March 12 to 19, 1999, at your facility. These examinations addressed areas important to public health and safety and were developed and administered using the guidelines of the "Examination Standards for Power Reactors" (NUREG-1021, Interim Revision 8).

Based on the results of the examinations, four of five reactor operator applicants and three of four senior reactor operator applicants passed all portions of the examinations. The preliminary conclusions of the examination activities were discussed between Mr. S. Dennis and Mr. P. Orphanos of your staff on March 19, 1999.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosures will be placed in the NRC Public Document Room.
