I am responding to the letter sent by Senator John Edwards to Chairman Richard Meserve, U.S. Nuclear Regulatory Commission (NRC), dated December 17, 1999, regarding a Freedom of Information Act (FOIA) request sent to NRC by Mr. John Warren, Executive Director of the North Carolina Waste Awareness Reduction Network.
