Dear Mr. Ray:

This refers to the inspection conducted on December 6 to 10, 1999, at the San Onofre Nuclear Generating Station, Units 2 and 3, facilities. The purpose of the inspection was to evaluate your overall response to Generic Letter 96-05, "Periodic Verification of Design-Basis Capability of Safety-Related Motor-Operated Valves." The enclosed report presents the results of this inspection.

The inspection results indicate that you have established and implemented a program to provide continued assurance that motor-operated valves within the scope of Generic Letter 96-05 are capable of performing their design-basis safety functions.

One unresolved item was identified during the inspection and is discussed in the report details. This item addresses a concern that certain design-basis scenarios may not have been considered in the calculation of worst-case operating conditions for some safety-related motor-operated valves. We understand that your staff will review this issue under Action Request 991200445.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and the enclosure will be placed in the NRC Public Document Room.
