Dear Mr. Caravelli:

The Embassy of Argentina has received a note # 3009/9 on December 29, 1999, from the "Autoridad Regulatoria Nuclear" (ARN), in reference to transference of one kilogram of low-enriched uranium, from the United States in the form of metal targets for testing and demonstration of the chemical processes for producing the isotope molybdenum -99. The Government of Argentina has confirmed the following:

- a. The transfer of the material, as identified in the license application, will be subject to all the terms and conditions of the Cooperation Agreement for the Civil Uses of Atomic Energy between the Government of the United States and the Government of Argentina, which entered into force on October 16, 1997.
- b. The consignee "National Atomic Energy Commission of Argentina", as identified on the application, is authorized to receive and possess the material.
