
We recently received the enclosed copy of the Federal Emergency Management Agency (FEMA) report for the Biennial Radiological Emergency Preparedness Exercise for the Byron Nuclear Generating Station conducted on August 25, 1999.

There were no Deficiencies for any jurisdiction identified. One Area Requiring Corrective Action (ARCA) was identified for Ogle County. There were no ARCAs for the State of Illinois. One prior ARCA for the State was resolved during the exercise.

We fully recognize that any corrective actions to be implemented may involve parties and political institutions which are not under your direct control. Nonetheless, we expect that assistance, if appropriate, will be extended.
