Please find enclosed endorsements 26 and 27 to Mutual Atomic Energy Liability Underwriters (MAELU) Certificate M-0031 that forms part of Master Policy No. 1, Nuclear Energy Liability Insurance (Secondary Financial Protection). In essence, Endorsement 26 (two pages) reflects the sale and transfer of ownership of Pilgrim Station, from Boston Edison Company to Entergy Nuclear Generation Company, that occurred on July 13, 1999. Endorsement 27 (two pages) also reflects the change in ownership of Pilgrim Station and pertains to Condition 2 of Policy No. 1 by way of a bond regarding the payment of retrospective premiums.

Please also find enclosed endorsements 35 and 36 to Nuclear Energy Liability Insurance Association (NELIA) Certificate N-0031 that forms part of Master Policy No. 1, Nuclear Energy Liability Insurance (Secondary Financial Protection). In essence, Endorsement 35 (two pages) reflects the change in ownership of Pilgrim Station. Endorsement 36 (two pages) reflects the change in ownership of Pilgrim Station and pertains to Condition 2 of Policy No. 1 by way of a bond regarding the payment of retrospective premiums.

Please also find endorsements 204 and 205 to NELIA Policy No. NF-0188. Endorsement 204 (one page) indicates that Item 1 of the policy declarations was amended to reflect the change in ownership of Pilgrim Station. Endorsement 205 (one page) reflects changes to the dollar amounts identified in Item 1 (advance premium) and Item 2 (standard premium and reserve premium) of Endorsement 201 and identifies an additional premium.



These endorsements are collateral to the sale and transfer of ownership of Pilgrim Station that occurred on July 13, 1999. The transfer was effectuated with the NRC's issuance of License Amendment No. 181, dated July 13, 1999 (Ltr. 1.99.080). Amendment No. 11 of Indemnity Agreement No. B-48 was issued as part of Amendment 181. After signature by Boston Edison Company and Entergy Nuclear Generation Company, the indemnity agreement was submitted to the NRC on August 9, 1999 (Ltr. 2.99.081).
