Subject: Authorization to Reproduce Copyrighted Documents

This letter is to renew the limited authorization provided to the NRC to reproduce copyrighted material submitted by ABB C-E Nuclear Power, Inc., (ABB). This authorization grants limited permission to reproduce material owned by ABB and submitted for NRC internal use in the performance of its legitimate regulatory functions pursuant to the Atomic Energy Act of 1954, as amended, and implementing regulations or other applicable laws. Consistent with the Berne Convention and Federal copyright law, it is ABB's position that copyright protection is provided to all documents created by ABB and its agents and employees upon creation of such documents, regardless of whether or not a copyright notice appears on the document. Thus, "copyrighted documents" are defined to include without limitation all reports, designs, diagrams, tables, and documents, whether in written or digital (electronic) format, in any medium (tape, disk, film, or e-mail) that are created by ABB, its agents or employees, in the course of their employment.

Moreover, it is ABB's position that duplication rights to ABB's copyrighted documents, as defined above, can be granted only by the copyright holder, unless such duplication meets the "fair use" exception of Federal copyright law. Accordingly, by this letter ABB authorizes the NRC to reproduce ABB copyrighted documents reasonably needed for its internal use, for filing in the NRC Public Document Rooms, and for limited distribution to members of the public who may request such documents from the NRC. In all cases where a copyright notice appears on the document, the copyright notice must also be included in all copies made by the NRC or by its Public Document Rooms' contractors.

The specific authorization provided herein supersedes any previous ABB authorization and remains applicable to ABB documents through December 31, 2000, unless rescinded by ABB via written notice to the NRC, or superseded by regulations in force covering the treatment of copyrighted submittals to the NRC. By providing this limited authorization to the NRC, ABB does not waive any other rights and protection it has related to its copyrighted documents, nor does this authorization extend to ABB proprietary documents, except that copies of proprietary documents may be made for strictly internal NRC use in accordance with 10 CFR 2.790(b)(6).
