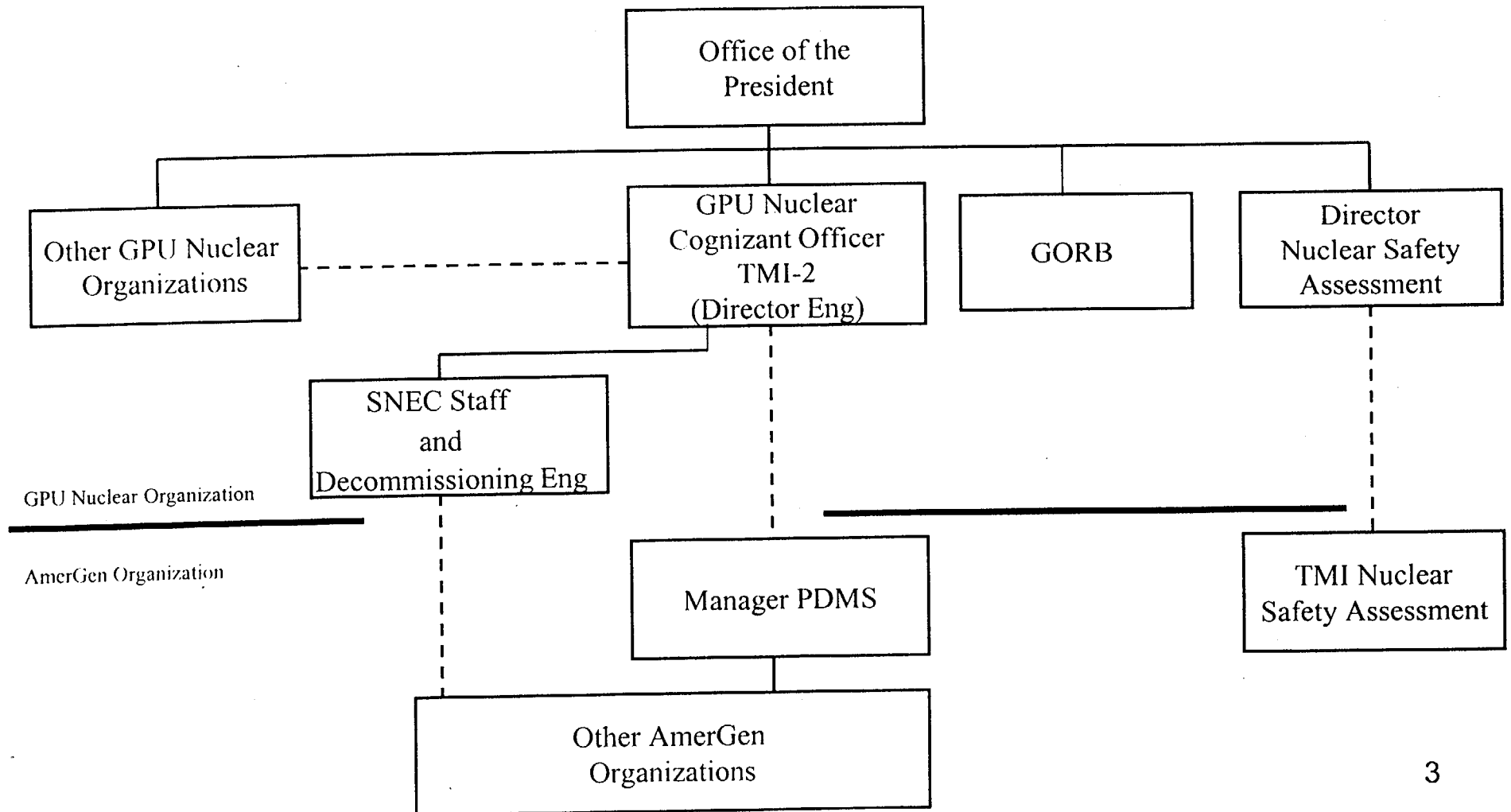

# Management under Monitoring Agreement post TMI-1 sale

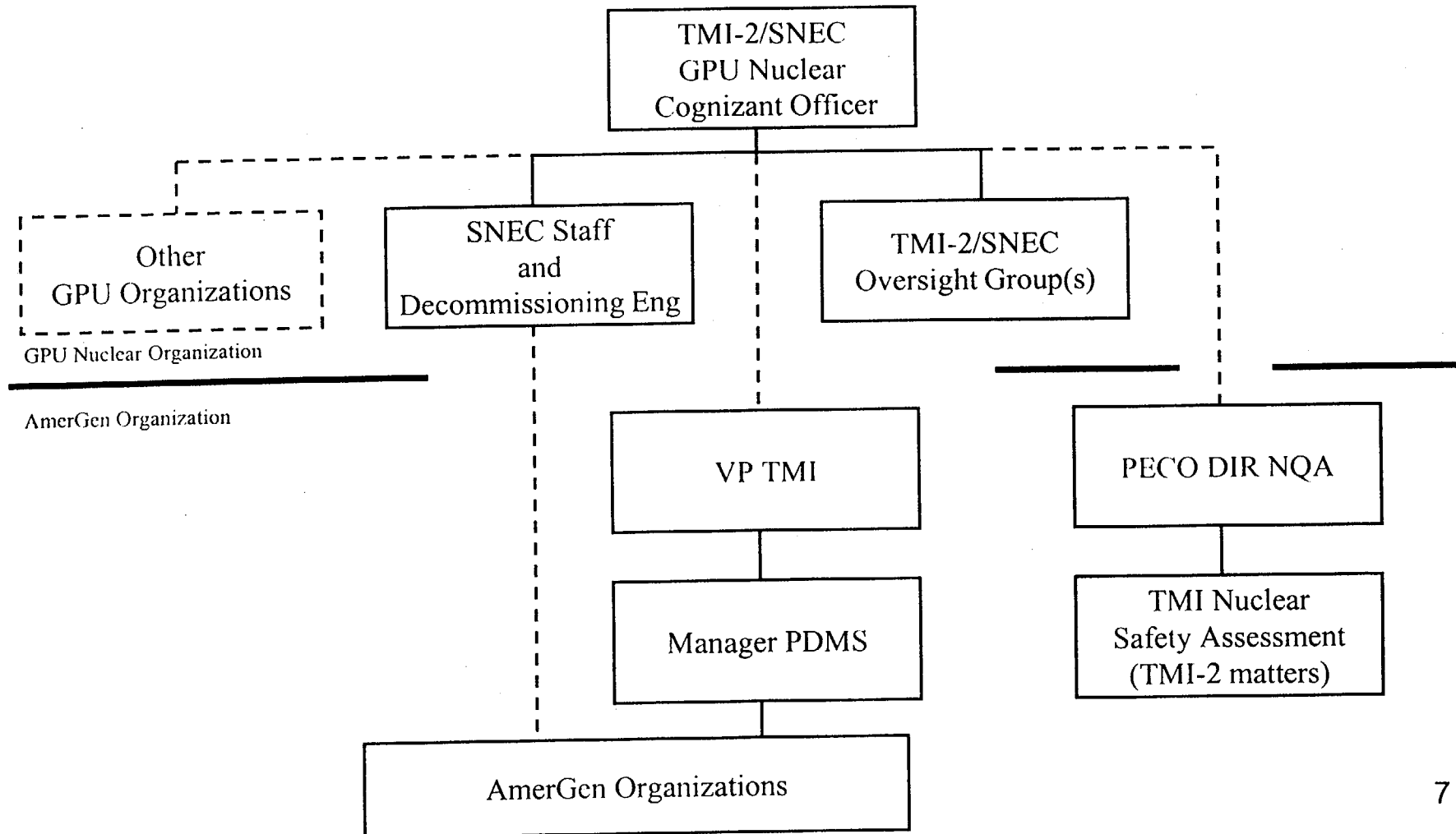


# **SNEC**

- **Continue to Provide Independent Oversight**
- **Transition Support Services for SNEC to TMI -1/AmerGen or Other Provider**
- **Amend the SNEC License and Related Documents to Reflect a Smaller Different GPUN Organization Structure After OC Sale**

# **GPUN Management Post Oyster Creek sale (cont.)**

## **GPU Nuclear Cognizant Officer TMI-2/SNEC**

- **Has Overall Responsibility for Maintenance of TMI-2 in PDMS Through the TMI-2 Monitoring Agreement**
- **Maintains Final Authority over TMI-2/SNEC Decisions**
- **Periodically Assesses AmerGen Performance in Meeting PDMS QA Plan, TS, and SAR Requirements**
- **Has Overall Responsibility for Decommissioning SNEC**
- **Signs Correspondence to State and Federal Authorities As Appropriate**

# **GPUN Management Post Oyster Creek sale (cont.)**

- **Sponsor of TMI-2/SNEC Oversight Group**
- **Obtains Specialized Support Services**
- **Obtains Support From Other GPU Organizations As Needed (E.G. Internal Audits, Contracts, Legal, Etc)**
- **Interface With Internal and External Stakeholder Groups**
- **LOSA, Budget Planning, and Amergen Contract Point of Interface**



# **Management under Monitoring Agreement (cont.)**

## **Nuclear Safety Assessment (AmerGen)**

- **Reports to GPU Nuclear Cognizant Officer on TMI-2 Related Matters Via PECO Director NQA**
- **Ensures the Quality Assurance Program Is Established and Implemented (TMI-2)**
- **Conducts PDMS TS Required Audits**
- **Periodically Monitors TMI-2 Activities**
- **Periodically Conducts IOSRG Evaluations and Assessments of TMI-2 Activities**
- **Provides Auditing, Monitoring, and Assessment for SNEC and Reports Results to Director SNEC and GPU Nuclear Cognizant Officer**

# **TMI-2/SNEC Oversight Committee--Post OC Sale**

## **Purpose:**

- **To Independently Assure That TMI-2 Structures, Systems, and Components Do Not Degrade in a Manner Which Threatens the Environment, Affects the Safety of Workers, or Significantly Impacts Future Dismantlement Activities.**
- **To Independently Assure That SNEC Matters Associated With Radiological Safety Implications Are Conducted Such That the Protection of the Public, Environment, Workers and All Aspects of Work Leading to Final Dismantling and Disposition Is Not Degraded.**
- **Committee Is Advisory to the GPU Nuclear Cognizant Officer.**

## **Primary Responsibilities:**

- **Assure Long Term Stability of TMI-2**
- **Independently Assess the Safety Implications of Work (Replaces TMI-2/SNEC GORB Function)**
- **Independent Review of All Audits (TMI-2/SNEC)**
- **Independent Review of Other Documents as Deemed Necessary (License and Technical Specification Changes, Facility Changes, Radiological Conditions, NRC Inspection Reports Corrective Actions, ETC.)**
