This refers to the inspection conducted on November 28, 1999, through January 8, 2000, at the Callaway Plant. The enclosed report presents the results of this inspection.

Based on the results of this inspection, the NRC has determined that two Severity Level IV violations of NRC requirements occurred. These violations are being treated as noncited violations, consistent with Section VII.B.1.a of the Enforcement Policy. These noncited violations are described in the subject inspection report. If you contest the violations or severity level of the noncited violations, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington, DC 20555-0001, with copies to the Regional Administrator, U.S. Nuclear Regulatory Commission, Region IV, 611 Ryan Plaza Drive, Suite 400, Arlington, Texas 76011; the Director, Office of Enforcement, U.S. Nuclear Regulatory at the Callaway Plant.
