Millstone Nuclear Power Station, Unit No. 2
Deviations from the Licensing Basis of the Safety Parameter Display System Updated Information

In a letter dated December 30, 1999, (1) Northeast Nuclear Energy Company (NNECO) provided the Staff an update to the remaining unresolved Millstone Nuclear Power Station Unit No. 2 (MP2) current licensing basis deviations with regards to the Safety Parameter Display System (SPDS). However, following this submittal and follow-up discussions with the MP2 Senior Resident Inspector, it was noted that one SPDS related item had not been adequately addressed. Specifically, it was noted that our licensing bases describes the SPDS as having color coded safety function status indicators and that this information had not been appropriately discussed in our response.

Although it was planned to modify the SPDS safety function indication panels to permit color coded safety function status indication, this action had not been formally docketed as a commitment. As a result, this letter is being submitted to serve that purpose. Presently, this activity is scheduled to be completed no later than the end of refueling outage 14.
