NRC STAFF RESPONSE TO
WASHINGTON PUBLIC POWER SUPPLY SYSTEM'S
MOTION FOR WITHDRAWAL OF APPLICATION


On January 4, 2000, Washington Public Power Supply System (Supply System)¹ filed a "Motion for Withdrawal of Application." In its motion, the Supply System requested the Licensing Board, pursuant to 10 C.F.R. § 2.107(a), to issue an order authorizing the withdrawal of the Operating License (OL) application at issue in the proceeding and

terminating the proceeding.² The NRC staff (Staff) has no objection to the Licensing Board's granting the Supply System's motion.³

² On January 11, 2000, the Licensing Board issued an Order (Schedule for Application Withdrawal Motion Responses) in which the Board directed that responses to the motion be filed by January 31, 2000.

³ Attached to the Supply System's motion is a letter to the NRC (Staff) dated December 21, 1999, in which the Supply System requests the Staff to terminate the construction permit (CP) for WNP-1.

The NRC staff plans to respond to the Supply System's request in much the same manner that it addressed the Supply System's request for termination of the construction permit for WNP-3 in 1996. These plans, which were noted with approval in the Licensing Board's order granting the Supply System's motion to withdraw its operating license application for WNP-3 and to terminate the proceeding, *Washington Public Power Supply System* (WPPSS Nuclear Project No. 3), LBP-96-21, 44 NRC 134 (1996), included meeting with the Supply System and interested state and local agencies, conducting a site inspection, and preparing an Environmental Assessment (EA) based on those activities and on any documentation the Staff might require pursuant to the Commission's regulations in 10 C.F.R. § 51.41. Here, as noted in the Supply System's motion, the stakeholders include the Department of Energy (DOE), which owns the Hanford Reservation on which WNP-1 is sited. Motion at 3-4. The Supply System states its expectation that the Staff will review site restoration environmental matters for WNP-1 and prepare an EA. *Id.* This statement accurately reflects the Staff's intentions.




