Revised Response to Administrative Letter 99-03

"Preparation and Scheduling of Operator Licensing Examinations"

Dear Sir/Madam:

NRC Administrative Letter (AL) 99-03, "Preparation and Scheduling of Operator Licensing Examinations," dated August 20, 1999, requested licensees to voluntarily submit a response concerning initial operator licensing examination needs, including an estimate of the number of applicants to be examined and intentions regarding the preparation of the examinations. By letter dated September 20, 1999, PECO Nuclear provided a response for both the Peach Bottom Atomic Power Station (PBAPS) and Limerick Generating Station (LGS) facilities.

Attachment 1 to this letter provides a revised response to AL 99-03 for Limerick Generating Station. The revised response: 1) reschedules the Limited Senior Reactor Operator (LSRO) initial licensing examinations from the calendar year CY2000 to calendar year CY2001; 2) changes the projected dates for the Reactor Operator (RO)/Senior Reactor Operator (SRO) initial licensing examinations for the calendar years CY2001, CY2002 and CY2003; and 3) reschedules the Generic Fundamentals Examinations from the first to second exam window for the calendar years CY2000 and CY2001. The revised operator licensing examination information is provided on the attached NRC Form 536.

During each of the calendar years CY2001 and CY2002, a total of eight (8) candidates are expected to take the dual site LSRO initial licensing examination as indicated in Attachment 1. The schedule for the indicated exam is as follows: the written exam and part of the operating exam will be given at LGS; the remainder of the operating exam will be completed at PBAPS.
