THE AMENDED U.S. NOTES AND ATTACHMENTS FOR THE PROPOSED TRANSFER WERE GIVEN TO MOFA IN FINAL FORM ON DECEMBER 29, 1999. THE CORRESPONDING GOJ NOTE, NO. 4/ASSN, DATED JANUARY 12, 2000, COVERING CASE NO. 488 IN U.S. NOTE NO. 507 DATED SEPTEMBER 1, 1999 AND AMENDED BY U.S. NOTE NO. 773 HAS BEEN RECEIVED IN THE EMBASSY'S EST SECTION.

2. THE TEXT OF THE GOJ NOTES IS EXACTLY THE SAME AS THE STANDARD TEXT USED PREVIOUSLY, REFTEL A, EXCEPT FOR THE FOLLOWING SPECIFICATION OF NUMBER AND DATE:
