3) Transportation and Route Schedule

The vessel will sail from Hamburg, Germany on July 18, 1999. The ocean transportation from Hamburg, Germany to Montreal, Quebec, Canada will be the responsibility of Canada Maritime Steamship Line. The vessel will unload at Montreal, Quebec, Canada on or about July 28, 1999. The containers will then be loaded onto the rail for importation to Detroit, MI. The containers will enter the USA at Detroit, MI on or about August 2, 1999, and will continue on rail to St. Louis, MO. 
