NOTICE OF WITHDRAWAL OF APPLICATION FOR AMENDMENT TO FACILITY OPERATING LICENSE

The U.S. Nuclear Regulatory Commission (the Commission) has granted the request of Northeast Nuclear Energy Company, et al. (NNECO) to withdraw its November 13, 1998, application, as supplemented by letter dated September 16, 1999, for proposed amendment to Facility Operating License No. DPR-65 for the Millstone Nuclear Power Station, Unit 2, located in New London County, Connecticut.

The proposed amendment would have authorized the licensee to revise the Final Safety Analysis Report by changing the High Pressure Safety Injection pump runout flowrate, Auxiliary Feedwater pump flowrate, the iodine partition factor for the air ejector, inclusion of the potential of flashing of the primary-to-secondary leakage, and a change in the atmospheric release point assumed following the actuation of the Enclosure Building Filtration Actuation Signal.

The Commission had previously issued a Notice of Consideration of Issuance of Amendment published in the FEDERAL REGISTER on January 27, 1999 (64 FR 4158).

However, by letter dated January 25, 2000, NNECO withdrew the proposed change request.
