This subsystem is under the Technical Conference Forum (TCF) of the NRC Home Page. The Office of Nuclear Material Safety and Safeguards has uploaded to the TCF the draft NRC Rulemaking Plan Revising 10 CFR Parts 40, 75, 110 and 150 with regard to "International Safeguards Access and Reporting Requirements for Licensees Processing Source and Special Nuclear Material, or Importing or Exporting Nuclear Fuel Cycle Related Material or Equipment." Your review and comment is invited on the draft Rulemaking Plan by **March 27, 2000**. Please provide comments to the extent you can either through the TCF or to the individual named below.

Due to its pre-decisional nature, this document is exempt from public disclosure under NRC rules. We request that you limit distribution to your staff and not release the document publicly.
