On November 24, 1999, Wisconsin Public Service Corporation (WPSC), Wisconsin Power and Light (WP&L), and Madison Gas and Electric (MGE) owners of the Kewaunee Nuclear Power Plant (KNPP), submitted an application requesting an order consenting to the transfer of operating authority for KNPP from WPSC to a newly formed operating company called Nuclear Management Company, LLC. This letter provides additional information that supplements our application request.
