Mr. Walter Scott, Jr. is the Chairman of the Board of Level 3 Communications, Inc., a communications and information services company, a Delaware Corporation, with executive offices in Broomfield, Colorado. Level 3 is a publicly traded company, which is not owned, controlled or dominated by non-U.S. interests. Level 3 Communications was formerly known as Peter Kiewit Sons', Inc., for which, until the spin-off of its construction operations in March 1998, Mr. Scott also served as Chief Executive Officer. Mr. Scott has been a MidAmerican
