MEMORANDUM AND ORDER
(Allowing Additional Time
For Withdrawal Motion Responses)

By order dated January 11, 2000, the Board provided the parties with an opportunity to file responses to the January 4, 2000 motion of applicant Washington Public Power Supply System (WPPSS) to withdraw its application for an operating license for its Nuclear Project No. 1 (WPN-1).¹ It is has come to the Board's attention, however, that its order apparently was not served upon all the parties to the proceeding. To ensure that all parties have an opportunity to address the WPPSS withdrawal motion, the Board is providing an additional opportunity to respond.

¹ In its motion, the applicant points out that although WPPSS is the applicant's name of record in this proceeding, WPPSS is now conducting business as Energy Northwest.

Accordingly, any additional party responses to the WPPSS January 4, 2000, motion (or the NRC staff's January 28, 2000 response to that motion) shall be filed on or before Friday, March 3, 2000.

As before, in addition to serving paper copies of its response on the Office of the Secretary and the members of the Licensing Board by regular mail, the Board requests that on the day of filing (i.e., mailing) each party who has the capability to do so send a copy of its response by facsimile transmission or internet e-mail to the two Board members, the Office of the Secretary, counsel for WPPSS, and counsel for any other party who previously has provided the requisite facsimile number/internet address for the record.² The Board also requests that no later than the date a party


