On November 24, 1999, IES Utilities Inc., an owner and the licensed operator of the Duane Arnold Energy Center (DAEC), submitted an application requesting an order consenting to the transfer of operating authority for the DAEC from IES Utilities Inc. to a newly formed operating company called Nuclear Management Company, LLC. The application also requested a conforming amendment to Operating License No. DPR 49 to include Nuclear Management Company, LLC as a licensee thereunder, and to designate Nuclear Management Company, LLC as the licensee authorized to use and operate the DAEC. This letter provides additional information that supplements the application request.

The referenced application identified the name and address of the successor licensee and the address of the principal officers of Nuclear Management Company, LLC as follows:



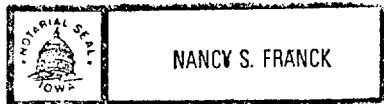


