## PROPOSED REVISION 27 TO THE

#### QUALITY ASSURANCE PROGRAM FOR STATION OPERATION (QAPSO)

#### REQUEST FOR ADDITIONAL INFORMATION

1. Regulatory Guide (RG) 1.123, "Quality Assurance Requirements for Control of Procurement of Items and Services for Nuclear Power Plants," Rev. 1, conditionally endorses ANSI N45.2.13-1976, "Quality Assurance Requirements for Control of Procurement of Items and Services for Nuclear Power Plants," as an acceptable method for complying with the requirements of Appendix B to 10 CFR Part 50 with regards to the control of procurement of items and services during the design, construction, and operations phases of a nuclear power plant. ANSI N45.2.13-1976 applies to "the work of any individual or organization participating in the procurement of those items and services from which satisfactory performance is required." ANSI N45.2.13-1976 also specifies that personnel performing verification activities be certified/qualified in accordance with ANSI N45.2.6, "Qualifications of Inspection, Examination, and Testing Personnel for Nuclear Power Plants."

In your December 20, 1999, submittal you proposed to eliminate the requirement for Quality Assurance (QA) personnel to perform an in-line review of procurement documents. Your letter also states that in lieu of QA personnel, line organization personnel will perform reviews of procurement documents in accordance with approved procedures and that such personnel will be trained accordingly.

Please clarify and indicate where commitments associated with the review of procurement documents by the line organizations, including their requisite training and qualification, are currently (or will be) identified in the QAPSO.

2. Table 17.1.7-1, "Conformance of Ginna Station Program to Quality Assurance Standards, Requirements, and Guides" — "Remarks," associated with Ginna's commitments to RG 1.33, Rev. 0, need to be clarified. For example, the text in "Substituted Criteria" does not currently reflect Ginna's proposed exception to the provisions in Section 4.3.1, "Personnel," of ANSI N18.7-1976. This table should reflect Ginna's proposal to use the provisions in ANSI/ANS-3.1-1987, Section 4.7, to define the qualification requirements for NSARB members in lieu of ANSI N18.7-1976, Section 4.3.1.
