Dear Mr. Mariotte:

On February 2, 2000, Mr. Paul Gunter of Nuclear Information and Resource Service (NIRS) spoke with Emile Julian of my office about the progress NIRS is making in obtaining a publically available copy of Attachment G to the NIRS petition. Mr. Gunter indicated that Attachment G is being released by British Governmental authorities but may have portions deleted from the released copy. Mr. Gunter also advised that as soon as NIRS has possession of a publically available copy of Attachment G that it will send the released version to the Commission on an expedited basis.

Once NIRS has the released version of Attachment G, it would be of help in consideration of your hearing request if NIRS compares the two versions of Attachment G and provides a statement to the Commission identifying those segments in the original Attachment G that have been removed from the released version, as well as an indication as to whether NIRS intends to rely on the withheld portions in support of its petition and the bases for that reliance.

As this case remains under active consideration by the Commission and, like all license transfer cases, is being handled on an expedited basis, we would appreciate your letting us know within seven calendar days the date on which you estimate filing the above documents.

This letter is also being served on those on the enclosed official service list. For all filings with the Commission during the course of this proceeding, please serve those on the list in addition to service on the Secretary. This requirement pertains to the notice you will provide within the seven calendar days of receipt of this letter as well as the results of your comparison requested in paragraph two. A copy of this letter is being served this date by e-mail. Because service by

e-mail is allowed under 10 CFR §2.1313, the seven calendar days for notifying the Commission begin on the day following receipt of the e-mail.
