Pursuant to 10 CFR 50.54(p)(2), Northeast Nuclear Energy Company (NNECO) hereby submits Revision 15A to the Millstone Nuclear Power Station Suitability, Training and Qualification Plan (ST&Q). An explanation of the changes to the ST&Q is contained in Attachment 1. The revision to the plan is provided as Enclosure 1.

The Millstone Nuclear Power Station Site Operations Review Committee has evaluated this revision pursuant to 10 CFR 50.54(p) and concurs that the revision does not decrease the effectiveness of the ST&Q. Pursuant to 10 CFR 73.21(b), the ST&Q is considered safeguards information and, as such, NNECO requests that the enclosed changes be withheld from public disclosure pursuant to 10 CFR 2.790(d)(1).
