Dear Mr. Plunkett:

On January 1, 2000, the NRC completed an inspection at your St. Lucie 1 and 2 reactor facilities. The enclosed report presents the results of that inspection.

During the inspection period, your conduct of activities at the St. Lucie facility was generally characterized by safety conscious operations. However, several significant problems were identified with the maintenance and upgrading of the Emergency Operating Procedures.

Based on the results of this inspection, the NRC has determined that four violations of NRC requirements occurred. These violations are being treated as a Non-Cited Violations, consistent with Section VII.B.1.a of the Enforcement Policy. These NCVs are described in the subject inspection report. If you contest the violations or the severity of these NCVs, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington, D.C. 20555-0001, with copies to the Regional Administrator, Region II, the Resident Inspector at your facility, and the Director, Office of Enforcement, USNRC, Washington, D.C. 20555-0001.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be placed in the NRC Public Document Room (PDR).
