Pursuant to 10 CFR 50.54(p)(2), Northeast Nuclear Energy Company (NNECO) hereby submits Revision 36 to the Millstone Station Physical Security Plan (PSP). An explanation of the changes to the PSP is contained in Attachment 1. The revision to the plan is provided as Enclosure 1.

The Millstone Nuclear Power Station Site Operations Review Committee has evaluated the revision pursuant to 10 CFR 50.54(p) and concurs that they do not decrease the effectiveness of the PSP. Pursuant to 10 CFR 73.21(b), the PSP is considered safeguards information and, as such, NNECO requests that the enclosed changes be withheld from public disclosure pursuant to 10 CFR 2.790(d)(1).
