Enclosed are copies of the proprietary and nonproprietary  
versions of Revision 2 to Westinghouse Topical Report  
WCAP 15128. The Revision 2 version of the Topical Report  
provides additional information requested by the staff in the  
reference letter. The report supports proposed Technical  
Specification (TS) Change 99-12, "Alternate Repair Criteria  
(ARC) for Steam Generators (S/G)," for SQN. This TS change  
is needed for the Unit 1 Cycle 10 refueling outage (which  
began February 22, 2000).

The Topical Report is currently planned to be utilized by  
both SQN and Diablo Canyon. As such, TVA and Pacific Gas and  
Electric (PG&E) are requesting that the billable manhours  
continue to be addressed in accordance with NRC's processes  
for generic review.

Enclosures 1 and 2 provide the application for withholding and  
affidavits (CAW-00-1386 and DCL-00-029) signed by Westinghouse  
and PG&E, the owners of the information, as well as the

proprietary information notice and copyright notices. The applications for withholding and the affidavits set forth the basis on which the information may be withheld from public disclosure by NRC and address the considerations listed in Paragraph (b)(4), Section 2.790 of NRC regulations.

Accordingly, it is respectfully requested that the information that is proprietary to Westinghouse and PG&E be withheld from public disclosure in accordance with 10 CFR, Section 2.790.


