Gentlemen:

This letter provides additional information with regard to the Request by The United Illuminating Company for Consent to Corporate Reorganization filed February 17, 2000.

1. The effective date anticipated for the corporate reorganization of The United Illuminating Company is May 31, 2000. Therefore, the consent of the NRC to the reorganization is needed on or before that date. If the NRC consent is obtained prior to May 31, 2000 and if other required government approvals have been obtained prior to that date, the completion of the corporate reorganization may be accelerated.

2. In the letter forwarding the Application and on the cover page of the Application the license number for Seabrook Unit 1 was mistakenly entered as NPF-56. The correct license number is NPF-86.

4. On and after the effective date of the corporate reorganization of The United Illuminating Company, the current members of the Board of Directors of The United Illuminating Company will be the members of the Board of Directors of the Surviving Corporation and of UIL Holdings Corporation.

The current officers of The United Illuminating Company will be the officers of the Surviving Corporation. UIL Holdings Corporation currently has two principal officers who occupy the same positions in The United Illuminating Company. These two officers will remain the principal officers of UIL Holdings Corporation on and after the effective date of the corporate reorganization.

All of the directors and all of the officers of the companies referred to above are citizens of the United States.
