PROTECTIVE ACTIONS

I. PURPOSE

This policy provides for implementation of offsite protective actions within the Emergency Planning Zone (EPZ) around the San Onofre Nuclear Generating Station (SONGS).

II. CONCEPTS

A. Protective Actions

1. Timely evacuation of the public prior to the release of radioactive materials to the atmosphere is an effective protective action.
2. Sheltering is an option which involves members of the public taking cover in a building that can be made relatively air tight.
3. Potassium Iodine (KI) will be administered to emergency workers upon recommendation of the ODAC coordinator and approval by the County of Orange and San Diego County Health Officers. KI will not be recommended for the public.

B. Responsibilities

1. All Offsite Jurisdictions

- a. Receive and assess information and recommendations from SONGS, the Offsite Dose Assessment Center (ODAC) and appropriate State and Federal agencies.
- b. Provide appropriate personnel monitoring equipment to emergency workers and ensure they are monitored for exposure.(See IP #23)
- c. Coordinate with other offsite jurisdictions and appropriate State and Federal agencies concerning options for protective actions.
- d. Implement protective actions for the population and areas within their jurisdiction.
- e. Designate evacuation routes and transportation assembly points.
- f. Coordinate with cities which host reception centers and the ARC for the monitoring, decontamination, reception and care of its citizens and visitors.

PROTECTIVE ACTIONS

2. State of California
 - a. The California Highway Patrol (CHP) has primary responsibility to establish primary evacuation routes with the assistance of CALTRANS and local law enforcement agencies.
 - b. The State Military Department, as directed by the Governor, will assist in evacuation, security, communications and logistical support as requested.
 - c. The Department of Parks and Recreation has responsibility for implementing protective actions for the State Beaches at San Onofre, San Clemente, and Doheny. State Parks will consider a precautionary closure of San Onofre State Beach and subunits nearest SONGS at the ALERT Emergency Classification Level.
 - d. The Department of Health Services can provide assistance in the following areas:
 - (1) Radiological Health Physics support during emergency phase.
 - (2) Lead Technical agency for post-emergency radiological assessment of off-site radiological contamination.
 - (3) Evaluation of Health Effects of any potential or actual releases.
 - (4) Enforces and administers the state's Safe Drinking Water Act which regulates certain large and small drinking water systems
 - (5) Enforces the Sherman Food, Drug, Cosmetic Law controlling the manufacturing, safety, packaging, labeling, holding advertising, and selling of foods, drugs, medical devices, and cosmetics and the effectiveness of drugs and medical devices.
 - (6) Surveillance over storage, packaging, transporting, and loading of all radioactive materials, and disposal of radioactive wastes.
 - (7) Reviews and approves specific plans submitted for the conduct of any studies involving the deliberate introduction of radioactive material into the environment.
 - (8) Perform long term surveillance of radioactivity levels in the environment.

PROTECTIVE ACTIONS

- (9) Analytical chemistry, radiochemistry, and environmental microbiology laboratory services
 - (10) Licensure and Medicare and/or Medi-Cal certification of more than 5,000 health facilities or programs.
 - (11) Conducts surveillance, sampling and testing of commercial and sport shellfish (mussels, clams, and oysters) growing and harvesting areas for contamination
3. Southern California Edison (SCE)
Make protective action recommendations to offsite jurisdictions.
 4. The County of Orange
 - a. Coordinate transportation for persons from evacuated areas and transportation assembly points to designated reception centers.
 - b. Coordinate with Operational Area members for the monitoring, decontamination and reception and care of citizens from the unincorporated area and in support to the other IPC members.
 - c. Department of Education
 - (1) Assist CUSD in the evacuation and care of school children.
 - (2) Coordinate with ARC and designated Reception Centers.
 - (3) Coordinate the notification of private schools.
 5. San Diego County
San Diego County has no citizens under its jurisdiction within the EPZ. However plant personnel and visitors to the beaches surrounding the plant evacuating southward will be received, monitored, decontaminated and sheltered under the direction of responsible officials.
 6. Camp Pendleton
Residents of Camp Pendleton will follow emergency instructions issued by base officials.
 7. Capistrano Unified School District (CUSD)
 - a. CUSD will be responsible for protective actions taken at district schools during school hours.
 - b. The Superintendent has independent authority to initiate protective actions for district schools.

PROTECTIVE ACTIONS

- c. Provide transportation for public school children.
- d. Provide supervision at Reception Centers for school children until they can be reunited with parents or guardians.

C. Protective Action Implementation

- 1. Protective Action Decisions (PAD) for the public will be broadcast over the Emergency Alert System (EAS).
- 2. Once the decision to take shelter, or to evacuate has been agreed upon by responsible officials, it will be carried out for the entire EPZ.
- 3. The County of Orange Health Officer, in coordination with the San Diego County Health Officer will issue the order for emergency workers to administer KI over the YPS and in writing. The order will be relayed to emergency workers by their respective controlling agencies.

UNANNOUNCED YELLOW PHONE SYSTEM DRILL**I. PURPOSE**

This policy describes the procedures for unannounced communications drills using the Yellow Phone System (YPS) to contact the jurisdictions of the San Onofre Interjurisdictional Planning Committee (IPC).

II. CONCEPTS

A. Southern California Edison (SCE) Off-site Emergency Planning/Emergency Planning (OEP/EP) shall activate the YPS at unannounced times during each month to test the effectiveness of established notification procedures. He/she shall maintain a log of contact times and responses and copies provided at the next IPC meeting.

III. PROCEDURES

SCE OEP/EP (*35) shall select the date and time of the monthly test based on the following guidance:

- A. The test shall be conducted monthly between the 5th and 25th of each month.
- B. The time of day shall be varied to ensure the day shift (7am-4pm), mid-shift (4pm-midnight), and night shift (midnight-7am) are equally tested. Periods of heavy communications traffic (i.e. 6-9am, 4-7pm, Friday and Saturday evenings) should be avoided.
- C. The SCE OEP/EP (*35) shall utilize the following verbal message when contacting each station via YPS:

“This is the San Onofre Nuclear Generating Station. We are conducting a notification drill for off-site jurisdictions. Please consult your Emergency Plan to familiarize yourself with the procedure you should follow. **DO NOT, repeat, DO NOT make actual notifications unless specifically directed to do so.**”

- D. In conjunction with the verbal notification he/she (*35) shall transmit the following “Hard Copy” YPS message:

“This is the San Onofre Nuclear Generating Station, we are conducting a notification drill for off-site jurisdictions. Please consult your Emergency Plan to familiarize yourself with the procedure you should follow. **DO NOT, repeat, DO NOT make actual notifications unless specifically directed to do so.**”

IV. IPC MEMBER JURISDICTIONS

IPC representatives for the Counties of Orange and San Diego, the Cities of Dana Point, San Clemente and San Juan Capistrano, California State Parks, California Highway Patrol, and U.S. Marine Corps Base Camp Pendleton shall:

- A. Determine the desired level of notification for each drill prior to the 1st day of the month and notify the appropriate communications center PRIOR to the 5th of the month.

*(It is not necessary for SCE OEP/EP (*35) to know what level each jurisdiction has determined. Once the YPS notification has been made the SCE liaison's task is complete.)*

- B. Direct jurisdictional communications centers (YPS Operators) to record the time of notification and any problems encountered during the drill.
- C. Be prepared to discuss the administration of the drill at the monthly IPC meetings.
