SUBJECT: Fitness-for-Duty Program Performance Data Report

In accordance with 10 CFR 26.71(d), attached please find the Omaha Public Power District (OPPD) Fitness-for-Duty Program Performance Data for the six-month period from July 1 through December 31, 1999.

Also, OPPD has determined that the Performance Data Report for the period January 1 through June 30, 1999 (as transmitted by Reference 2) provided erroneous counts for the number of licensee employees tested. The number for pre-access tests should have been 14 instead of 9, while the corresponding total number for licensee employees tested should have been 232 instead of 227. All other numbers were correct. A revised Performance Data Report is attached. We apologize for any inconvenience caused by these errors. These errors are considered insignificant because the actual number of licensee employees tested was higher than originally reported, while the number of positive test results remained at zero.

I. MANAGEMENT ACTIONS

- A. Four (4) contractor employees tested positive during pre-access drug and alcohol testing. OPPD terminated their services and referred them to their respective contractor companies.
- B. Two (2) contractor employees tested positive during "for cause" drug and alcohol testing. OPPD terminated their services and referred them to their respective contractor companies.
- C. One (1) contractor employee was prevented from entering the protected area during shift change due to the smell of alcohol. This contractor left the site with another contractor prior to arrangement of a "for cause" drug and alcohol test. OPPD terminated the individual's services and notified the individual's supervisor.
- D. Due to an administrative error by the contracted medical service provider, the number of blind specimens they submitted to the laboratory on behalf of OPPD during the third and fourth quarters of 1999 was less than 10% of the total number of drug tests performed during those two quarters. Personnel associated with administration of the blind specimens for OPPD's Fitness for Duty Program have been made aware of this error, and further actions to prevent recurrence have been established. In addition, the provider immediately took corrective action and submitted the complementary number of blind specimens plus additional blind specimens to the laboratory to compensate for this error.
