Dear Mr. Basnight,

Thanks so much for your response to my concern about preserving the natural beauty and resources of North Carolina. As part of my concern to take care of our land, water, and people, I'm very concerned that CP & L is planning to double its storage of spent nuclear fuel at the Shearon Harris plant near the Cape Fear River Basin, and only a few miles by air from Jordan Lake and other rivers that feed into the Cape Fear. Nuclear pollution is by far our worst danger as we enter the 21st century. It is so dangerous, lasts so long, affects our health and welfare for so many thousands of years.

Whatever you can do to help we here in the Triangle area so much appreciate. Somehow we must think toward the long range health and welfare of our land and people, not just toward the short term goals of corporate wealth and profit.

You no doubt know that the Triangle area now has some of the worst air in the country (last summer we had many red and orange alert days, elderly and children were told to stay inside), about half from coal-burning factories and about half from automobile traffic. We must work together to keep our state a good place to live. I know that we have attracted industries and companies here because North Carolina is such a nice place to live. But it is losing that quickly, sadly.

Keep up the good work and let's keep North Carolina beautiful and our people healthy.
