On December 20, 1999, Public Service Electric & Gas Company (PSE&G), submitted to the U.S. Nuclear Regulatory Commission (NRC) the subject request. The submittal is seeking NRC's consent to the transfer of the minority non-operating interests of Atlantic City Electric Company and Delmarva Power and Light Company in the Salem and Hope Creek Generating Stations, to PSE&G. Eventually, as part of the proposed corporate restructuring, PSE&G will transfer these interest shares, as well as its existing shares in the Salem and Hope Creek Stations, to the proposed new electricity generating company: PSEG Nuclear.
