INSTRUCTIONS TO STUDENTS

<u>ACCEPTANCE</u>: This is to advise you that those individuals in Enclosure 1 have been accepted for participation in the Training Course (H-314), "Safety Aspects of Well Logging." <u>COURSE</u>: The course starts at 8:00 a.m. each morning beginning on Monday, May 1, 2000. The daily sessions will end at approximately 5:00 p.m. each day except that the course will end at noon on Friday, May 5, 2000.
