Dear Ms. Lee:

I refer to the letters from your office dated December 17, 1999 and January 5, 2000 requesting the views of the Executive Branch as to whether issuance of an export license in accordance with the application hereinafter described meets the applicable criteria of the Atomic Energy Act of 1954, as amended:

NRC No. XSNM03130—Siemens Power Corporation has applied for authorization to export to Japan 67 kilograms of U-235 contained in 1,621 kilograms of uranium enriched to a maximum of 4.95 percent in the form of uranium dioxide for the initial supply to Unit 1 of the Shika Nuclear Power Station.

It is the view of the Executive Branch that the proposed export will not be inimical to the common defense and security of the United States, and is consistent with the provisions of the Atomic Energy Act of 1954, as amended.

The proposed export to Japan would take place pursuant to the 1988 Agreement for Cooperation Between the United States and Japan, as reported in U.S. Embassy Tokyo telegram 1604, dated March 5, 2000, a copy of which is enclosed.

On the basis of the foregoing, the Executive Branch recommends that the license be issued.
