MEMORANDUM AND ORDER
(Making Publicly Available Decision
Regarding Contention Utah E/Confederated
Tribes F and Extending Discovery Period)

By memorandum and order issued March 10, 2000, the Licensing Board ruled on a partial summary disposition motion regarding contention Utah E/Confederated Tribes F, Financial Assurance. See LBP-00-06, 51 NRC __ (Mar. 10, 2000). In a separate memorandum issued that date, the Board advised all the parties to this proceeding that it had crafted its March 10, 2000 decision to avoid using 10 C.F.R. § 2.790 "proprietary information" so the issuance could be publicly released, but nonetheless was treating its ruling as confidential pending receipt of the views of the parties involved with the motions on whether the decision could be publicly released. As part of a March 17, 2000 submission, applicant Private Fuel Storage, L.L.C. (PFS), advised the

Board that it has not identified any proprietary information in the March 10, 2000 decision and so has no objection to making that issuance publicly available. See Joint Report on Matters Requested in LBP-00-06 (Mar. 17, 2000) at 3 [hereinafter Joint Report].

Accordingly, included as Attachment A to this memorandum and order is a copy of LBP-00-06 as issued, which shall be made part of the public record of this proceeding. The published version of this decision will omit the designation "HANDLE AS PROPRIETARY INFORMATION PENDING REVIEW" that is found on the bottom of each page.¹

Additionally, in that March 17, 2000 submission, the parties indicated that additional time is required to complete the depositions of intervenor State of Utah (State) witnesses Dr. Marvin Resnikoff and Matthew Lamb regarding contention Utah H, Inadequate Thermal Design, that previously were scheduled to be finished on or before March 9, 2000. See Joint Report at 4-5. The Board grants the parties' proposed extension of the discovery period in

that the depositions of Dr. Resnikoff and Mr. Lamb shall be completed on or before Friday, March 31, 2000.




