AFFIDAVIT

Comes the Affiant, Richard Hill, under oath and of legal age, and states:


1. I am Richard Hill and I live at 3800 W. H & H Rustic Lane, Madison, Indiana 47250.
2. I am a member of Save The Valley, Inc., whose address is P.O. Box 813, Madison, Indiana 47250.
3. I live approximately five (5) miles from the Jefferson Proving Ground.
4. I have concerns about the decommissioning plan for the DU area. These concerns include the vagueness of the planned extent of the cleanup, the vagueness of the plan for future monitoring of the DU area and areas downstream, and the vagueness of the planned procedures that will be employed to ensure that the DU area remains restricted.
5. To be more specific, in part 5.0 Completing the Decommissioning, it is stated that " . . . collection of DU fragments deposited in the soil surface would be a cost effective means to keep the exposure of humans and animals to residual radiation as low as reasonably achievable." However, it is not clear that such a collection is actually the option that will be pursued. Further, a plan should be in place to periodically reevaluate the area for further cleanup if additional DU should migrate to the surface due to freeze/thaw effects, erosion, or other means.
6. Part 5.0 also states that " . . . continued environmental monitoring of soil concentrations, groundwater, surface water, and possibly plants and animals will provide the data to show the

potential doses delivered to site users, people who use water downstream from the impact area, and animals living in the impact area". However, I do not find in the plan any assurance as to how often and for how long monitoring would be implemented.

7. I agree that the DU area should be considered for restricted use only. However, more details are needed as to how this will be accomplished.

8. Another concern involves my use of Big Creek as a recreational area. I periodically fish in Big Creek on sections downstream from the DU area (outside of the boundaries of JPG). I am concerned about any potential contamination to the fish and other wildlife in and along Big Creek. These concerns include potential harm to the fish populations, as well as other wildlife.



8. I give my consent for Save The Valley, through its president, Richard Hill, to represent my interest in requesting a hearing on the DU Decommissioning Plan for JPG.




