Enclosure 1 to this meeting summary provides a list of the meeting attendees. Enclosure 2 provides a copy of slides that were used by the NRC and Duke to summarize the status of the review of the LRA.

The staff and Duke noted the accomplishments since that last management meeting in January. These accomplishments included issuing the safety evaluation report ahead of schedule, conducting the final regional based inspection at the site, and supporting both an Advisory Committee on Reactor Safeguards (ACRS) subcommittee meeting and full committee meeting. The staff and Duke noted that before the Commission paper is forwarded the following actions need to be taken: the form and content of the renewed license has to be discussed, the staff needs to review the updated final safety analysis report supplement related to license renewal, and Region II and the ACRS need to issue their respective recommendation letters. The staff believed that the review was progressing as scheduled. Duke commented that unless problems occur, they do not believe an April management meeting is necessary and that future Duke management meetings would be limited to participating in the License Renewal Steering Committee meetings.
