This letter submits CE Owners Group Joint Applications Report (JAR) for DC Power Source AOT Extension, report CE NPSD-1184. Enclosed for your use are 12 copies of the report. The enclosed report provides a technical basis for changing the DC power source Technical Specifications. The enclosed report was developed using the joint application/cross comparison process pioneered by the CEOG to support risk informed decisions.

The safety evaluation prepared by the NRC should specifically identify the acceptability of the results to the plants referenced in CE NPSD-1184 and should identify any additional information required to be provided when the plant specific license amendment requests are submitted to the NRC for approval.
