On March 17, 2000, I spoke by telephone with Mr. David Lochbaum, one of four petitioners of a 10 CFR 2.206 Petition requesting that the Nuclear Regulatory Commission order that Indian Point 2 (IP2) remain shutdown until the plant's four steam generators are replaced and two other issues are resolved. The purpose of the call was to determine a mutually agreeable date for a Petitioner-requested public meeting, the purpose of which was to provide an opportunity for the Petitioners to provide additional information in support of their Petition.

Mr. Lochbaum stated that he had discussed the meeting schedule with the other three Petitioners, and that their preferred date for the meeting was April 7, 2000. They could meet as early as April 6, 2000, but that date would create some inconvenience. I stated that there was no conflict on my calendar, although we would have preferred to have held the meeting sooner. I stated that if my management had no conflicts with that date, I would schedule the meeting for the afternoon of April 7. We discussed the length of the meeting, and agreed that 2 hours should be sufficient, with 1 hour allotted to the Petitioners and 1 hour allotted to the licensee. Mr. Lochbaum indicated that he tentatively expected seven or eight attendees at the meeting.
