



In consideration of Modification Ninety, the Contractor hereby releases the Government from any and all liability under this contract for further equitable adjustments attributable to such facts or circumstances giving rise to the Contractor's proposal for adjustment dated October 19, 1999.

Except as provided herein, all other terms and conditions of the contract remain unchanged and in full force and effect.
