The purpose of this modification is to:

1. Decrease the contract ceiling amount by \$95,098.57 from 817,929.00 to \$722,830.43.
2. Revise Subsection G.1, entitled, "Indirect Cost Rates," to incorporate the final negotiated indirect rates identified in the Defense Contract Audit Agency Report No. 6311-95D10250657.

Accordingly, the contract is hereby modified as follows:

- (1) Under Section G - Contract Administration Data, Subsection G.1 - Indirect Cost Rates is deleted in its entirety and the following is substituted in lieu thereof:

"G.1. INDIRECT COSTS RATES

For this contract, the maximum allowable indirect cost rates for reimbursement of indirect costs are as follows:

- a. The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$722,830.43."

All other terms and conditions under this contract remain unchanged.
