Dear Ms. Borener:

I am conveying to you in this letter, Modification No. 2 to the subject Agreement which provides incremental funding in the amount of \$88,406.43. Accordingly, the Agreement is modified as follows:

Article V, "Obligation of Funds," is modified to read as follows.

"The amount presently obligated by the NRC for this Agreement is \$168,406.43. The obligated amount may be increased as mutually agreed by written modification to this Agreement. When and if the amount(s) paid and payable to DOT/RSPA/Volpe hereunder shall equal the obligated amount, DOT/RSPA/Volpe shall not be obligated to continue performance of the work unless and until additional funds are obligated with respect to this Agreement.

It is estimated that the amount currently allotted will cover performance under this Agreement through August 19, 2001."

This modification obligates FY00 funds in the amount of \$88,406.43.


