The purpose of this modification is to:

1. Exercise the third option year of the contract in accordance with Federal Acquisition Clause 52-217-9, entitled, "Option to Extend the Term of the Contract," and Contract Clause A.4, entitled, "Duration of Contract Period." As a result of this action, the ceiling amount of the contract is increased by \$45,500.00 from \$136,500.00 to \$182,000.00.
2. Extend the contract period of performance through February 9, 2001.

Accordingly, the contract is hereby modified as follows:

- (1) Under Subsection B.7- CONSIDERATION AND OBLIGATION--DELIVERY ORDERS Paragraph a is deleted in its entirety and the following is substituted in lieu thereof:

"CONSIDERATION AND OBLIGATION -- DELIVERY ORDERS  
(JUN 1988)

- (a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$182,000.00. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the contract period provided such orders are within any maximum ordering limitation prescribed under this contract."

- (2) Subsection A.4 - DURATION OF CONTRACT PERIOD is deleted in its entirety and the following is substituted in lieu thereof:

"DURATION OF CONTRACT PERIOD

The period of performance for this contract shall commence on February 10, 1997, and expire on February 9, 2001. The term of this contract may be extended at the option of the government for one additional year."

There is no funding activity for this contract modification.

All other terms and conditions under this contract remains unchanged.
