The purpose of this modification is to extend the period of performance of the subject contract at no additional cost to the NRC to allow time to complete the decommissioning activities at the watershed study area of the Apache Leap Research site in accordance with Modification No. 11 under the contract. NOTE: Signatures are required from the University of Arizona for Modification No. 12 and the attached Contractor's Release Form (ATTACHMENT 1) and shall release the NRC from any future claims. Accordingly, the following change is hereby made:

1. Section F.5, "DURATION OF CONTRACT PERIOD," is deleted in its entirety and the following is substituted in lieu thereof:

"This contract shall commence on 5/9/95 and expire on 4/30/2000."

All other terms and conditions under this contract including the ceiling amount of \$841,886.57 remains unchanged.
