AmerenUE has endorsed the Nuclear Energy Institute's Guideline for Managing NRC Commitments. The Guideline has been incorporated into Callaway procedure APA-ZZ-00540, Commitment Management Program. The following Callaway Commitments deleted between refuel nine, May, 1998 and refuel ten, November, 1999 meet the criteria of the NEI Guideline for those Commitments deleted or revised requiring NRC notification within the next refuel outage interval summary report.
