ONSITE PROPERTY INSURANCE COVERAGE

Ladies and Gentlemen:

In accordance with 10 CFR 50.54(w)(3), Carolina Power & Light Company (CP&L) hereby submits information regarding the present level and source of onsite property damage insurance at the Brunswick Steam Electric Plant, Unit Nos. 1 and 2, the Shearon Harris Nuclear Power Plant, Unit No. 1, and the H. B. Robinson Steam Electric Plant, Unit No. 2. This information is required to be submitted to the NRC by April 1 of each year.


CP&L has in full force and effect with Nuclear Electric Insurance Limited (NEIL), primary nuclear property insurance for each reactor site in the amount of \$500,000,000 which expires April 1, 2000. This coverage is renewed effective April 1, 2000, for the period of April 1, 2000 to April 1, 2001.

CP&L also has in full force and effect with Nuclear Electric Insurance Limited, excess nuclear property insurance for each reactor site with limits of \$1,400,000,000 for the Brunswick Steam Electric Plant, Unit Nos. 1 and 2, \$2,000,000,000 for the Shearon Harris Nuclear Power Plant, Unit No. 1, and \$800,000,000 for the H. B. Robinson Steam Electric Plant, Unit No. 2, covering the period of April 1, 1999 to April 1, 2000. The excess nuclear property insurance coverage is renewed effective April 1, 2000, for the period April 1, 2000 to April 1, 2001.
