SUBJECT: CORRECTIONS TO LICENSE AMENDMENT 6, LICENSE NO. SUA-1534

Dear Mr. Griffin:

This letter corrects two errors in License Amendment 6. When License Amendment 6 was printed, License Condition 9.4 A(2) was not printed. This license condition allowed the licensee to make changes in the approved application. In the enclosed license, this condition has been correctly printed.

In addition License Condition 10.9 correctly referenced Regulatory Guide 8.31, but cited the wrong title. Therefore, instead of "Health Physics Surveys in Uranium Recovery Facilities," the title has been corrected to "Information Relevant to Ensuring That Occupational Radiation Exposures at Uranium Recovery Facilities Will Be as Low as is Reasonably Achievable."

Condition 10.9 has now been revised to state:

"The licensee shall be required to use a Radiation Work Permit (RWP) for all work or non-routine maintenance jobs where the potential for significant exposure to radioactive materials exists, and for which no standard written operating procedure exists. The RWP shall be issued by the CRSO, or designee qualified by way of specialized radiation protection training, and RWPs shall include, as a minimum, the information described in Section 2.2 of Regulatory Guide 8.31, "Information Relevant to Ensuring That Occupational Radiation Exposures at Uranium Recovery Facilities Will Be as Low as is Reasonably Achievable."
