Gentlemen:

Enclosed are the original and three copies each of Revision 6, Change 3 of the Waterford 3 Safeguards Contingency Plan (Enclosure 1) and Revision 6, Change 2 of the Security Training and Qualification Plan (Enclosure 2), which are submitted in accordance with 10CFR50.54(p). The plan changes were approved and implemented on September 24, 1999. Please note that these plan changes should have been included with the submittal of Revision 19, Change 1 of the Waterford 3 Physical Security Plan on November 16, 1999. Consequently, Entergy Operations failed to meet the requirement for submittal within 2 months of approval for the enclosed procedure changes. This non-compliance has been entered into our Corrective Action Program. This submittal is provided under affidavit per requirements of 10CFR50.

The Waterford 3 Plant Operations Review Committee has concluded that the changes to the Waterford 3 Safeguards Contingency Plan and the Security Training and Qualification Plan do not constitute a decrease in the safeguards effectiveness of the plans. The major change includes discontinuing the use of the baton as a defensive weapon and replacing it with an incapacitating agent.



In addition, this affidavit is submitted according to the provisions of 10CFR2.790 which allows for the proprietary treatment of the attached document. Entergy Operations, Inc. requests that the entire content of the attached Safeguards Contingency Plan and Security Training and Qualification Plan be withheld from public disclosure, pursuant to the provisions of 10CFR73.21 and paragraph (b)(4) of 10CFR2.790, subject to Commission Approval. These documents were reviewed in accordance with applicable regulations, and describe Waterford 3 Plant Security practices which are considered to be information customarily held in confidence by Entergy Operations, Inc. and is being submitted to the Commission in confidence.
