SUBJECT:	MANUAL CHAPTER 0609, SIGNIFICANCE DETERMINATION PROCESS

Attached is Manual Chapter IMC 0609, Significance Determination Process. The document, which was provided to your staff by email earlier this week, consists of a general description of the process, SDPs supporting each cornerstone (Appendices A - H), and enforcement, appeal and other SDP-related guidance (Supplements 1-4). The Shutdown Safety SDP (Appendix G) and the Containment SDP (Appendix H) are being issued for implementation, however, we will continue with feasibility reviews that should be completed by the end of April. Since your staff did not have an opportunity to review some of the changes described below and the document has been substantially revised to address previously submitted comments from the regions and pilot program lessons learned, we would appreciate any feedback over the next several weeks.

Please note that the Phase 2 plant specific worksheets for the reactor safety SDP have not all received the planned site visit review. Site visits are in progress. Until such time that the site visits are completed and the results incorporated into the worksheets, risk analyst review should be conducted for all Phase 2 evaluations to assure there is appropriate conservatism in the results. Note that NRR's Probabilistic Safety Assessment Branch has formed an operations support team to assist the regions in this effort throughout the period of initial implemention.

The following significant changes, have been made to IMC 0609 (Significance Determination Process) since it was last issued in DRAFT form in August 1999.

- Re-organization The Chapter has been reorganized into a main body dealing with guidance applicable to <u>all</u> cornerstone SDPs, Appendices dealing with <u>specific</u> SDPs, and Supplements giving more detail for certain program aspects than was warranted in the main body. Each Appendix will eventually contain both user guidance for that SDP and basis information. This work is an ongoing improvement initiative.
- 2. SDP and Enforcement Review Panel Procedures Detailed process and procedural guidance is provided in para. 0609-08 and in Supplement 1. Para. 0609-08 clarifies the designation of findings as Unresolved Items, the use of "apparent significant"
